- Coaching Application Updates
 - Our Coaching Application is being changed from submitted a PDF to now submitting via Google Form
 - Allows for easier tracking
 - Allows coaches to upload their certifications and we can host on our google drive
- Locker Room Policy
 - Todd working on creating policy and will present to board for approval at next meeting
- Rink Email to Jim Eister
 - Club is reaching out to Jim for rink improvements and to ask for a partnership to make our DVHL and potential CPIHL home
 games successful
 - Todd will get with Kirk to have the email sent to Jim
 - Hope is to have in-person meeting with Jim this spring/summer for further discussion and to move forward with improvements
- New App to replace Sports Engine
 - Club pays \$136 per month for Sports Engine to only use the chat/RSVP functionality
 - CPIHL also uses SE but they control creating our teams
 - Club uses Stack Sports for our Registration. Stack Sports also have an app and its Free to us
 - Todd to look into the Stack Sports app. Will setup app and test it out to see if we can use this and get rid of Sports Engine saving the club money.
- CPIHL Topics
 - 4% increase in ice cost to \$395 hr. for black bear rinks.
 - Form 1 is due August 1. (Teams and Division).
 - Player Registration due August 1 requires 2024 USA hockey #
 - Sept 6 Form 2 signed school district form due.
 - Sept 6 Signed copy of USA hockey roster due.
 - Possibly 3 varsity levels next year and NO JV (Bears, Viola, Rotherrock.)
 - Travel hockey coaches are not permitted to ban players from playing school hockey
 - Looking at getting back to 18 Varsity games.

 - Commitment Letters for 18U team will be sent out on Wednesday April 24th
 - Commitment Letters for 10U/12U/14U will be sent out after the showcase weekend
